#### Convene

# **Those Wishing to Address the Board**

Matt Cain wished to address the Board at this time. He states he does not live in Fayette County, but sits on the Clinton County Board of Health. Since his 4 years on the County Health Board they have gone through 3 Directors. He has no complaints regarding Fayette County Health Department and stronger believes that it is run well. He plead with the Board to "do the right thing."

# **Those Wishing to Address the Board**

Josh Jahraus addressed the Board stating he is the general manager at Wabash factory in Farina. He states that he cannot speak to the allegations. Prior to the pandemic he had no experience with health departments. During an outbreak at his facility he dealt with many health departments, but Fayette County Health Department was the most descriptive. He goes to say it was hard to get information from other health departments and Fayette County Health Department was very organized. When the vaccine rolled out the Wabash facility qualified for early vaccine and Fayette County Health Department was the only health department willing to come to their location to vaccinate.

Melissa Storck wished to address the board at this time. She states that she does run a tight ship. She states she always tries to be kind and loving. She states she will be forever grateful for those who support her. She has forgiven those who have wronged her. Melissa then asked the Fayette County Health Department employees for focus on our moto and to not give into gossip. Melissa then stated she would offer her resignation, asking for a fair separation agreement and the signing of a resignation contract.

Joe Wills entered a motion to strike out the vote of no confidence due to Melissa Storck's offer of resignation. Jenny Waggoner seconded the motion. All were in favor; none opposed. Motion carried.
